Avalogtrade Markets (Pty) Ltd ("we", "us" or "Avalogtrade Markets"), is a company registered and headquartered in South Africa (registration number: 2020/595755/07), and a financial service provider authorised and regulated by the Financial Sector Conduct Authority ("FSCA") under FSP license number 51268, governed by the Financial Advisory and Intermediary Services Act, 2002 (Act No. 37 of 2002).

2. COMMITMENT

Avalogtrade Markets is committed to protecting the privacy of all personal information which it obtains from you, including the information obtained during your visits to this website or the provision of other services to you. Avalogtrade Markets will only use your personal information in accordance with this Privacy Policy and otherwise in accordance with the Protection of Personal Information Act, 2013, as amended from time to time.

3. Avalogtrade MARKETS COLLECT PERSONAL INFORMATION

Avalogtrade Markets collects certain personal information in order that it may meet the needs of its customers. By collecting certain personal information, Avalogtrade Markets can monitor and improve the services which it offers to its existing and potential customers. We will use this information for the following purposes: establishing and maintaining your account, providing our services to you, improving our services, regulatory notifications and marketing.

4. WHAT INFORMATION DOES Avalogtrade MARKETS OBTAIN?

Avalogtrade Markets will collect and hold information about you when you complete an online application or other type of form or access and trade on your account through this website or another service, we provide to you. Avalogtrade Markets may derive information from your use of this website or another service we provide to you and may store this information with your personal profile. - Avalogtrade Markets; to develop an understanding of the products and services that

may be interested in obtaining from Avalogtrade Markets.
- to provide you with information or opportunities that we believe may be relevant to
you.
- to tailor the website or other service we provide to you to your needs and interests;
and
- to create anonymized statistical data.

You consent to Avalogtrade Markets using your personal information for the above-stated purposes. You also consent to Avalogtrade Markets transferring your personal information out of South Africa where this is necessary for Avalogtrade Markets to fulfill its contractual obligations to you. Please note that Avalogtrade Markets only transfers personal information to organizations out of South Africa if Avalogtrade Markets has assessed the organization as having appropriate controls and safeguards in place to protect your personal data.

6. WHO MAY Avalogtrade MARKETS DISCLOSE THIS INFORMATION TO?

Avalogtrade Markets may be required to provide your personal information to the regulator and government bodies from time to time. Avalogtrade Markets may also disclose your personal information to:

- financial institutions and other similar organizations that deals within the course of its corporate activities, or those that are nominated by you.
- external service providers and professional advisers (which may be located overseas) that provide services to Avalogtrade Markets.
- any organization at your request or any persons acting on your behalf, including your financial adviser, broker, solicitor or accountant.
- any third parties where this is necessary to process a transaction or provide services which you have requested; or
- any authority to whom Avalogtrade Markets is required to disclose such information by law. Please note that Avalogtrade Markets does not sell or provide your personal information to third parties for marketing purposes.

7. UPDATING YOUR INFORMATION

You may inform Avalogtrade Markets at any time that your personal details have changed or that you wish Avalogtrade Markets to delete personal information we hold about you by emailing us at info@Avalogtrademarkets.com. Avalogtrade Markets will change or delete your personal information in accordance with your instructions, except to the extent that we are required to hold your personal information for regulatory or legal purposes, to provide you with the services you have requested or to maintain adequate business records.

9. COOKIES

If a complaint is not resolved by Avalogtrade Markets to your satisfaction, you may complain to the Information Commissioner.

Under data protection legislation, you have (subject to certain exceptions) the right to obtain copies of any personal information which Avalogtrade Markets holds about you and to inform Avalogtrade Markets of any inaccuracy. If you have a request, please contact us to obtain a subject access request form. We may charge a nominal fee to cover the cost of verifying the application and locating, retrieving, reviewing and copying any material requested.

12. YOUR CONSENT
